



## Upgrade Pathway – TAE40116 to TAE40122.

The new TAE40122 is 12 units of competency.

The TAE40116 was ten units nine being core.

### **Packaging Rules for TAE40122**

**6 core units** plus

**6 elective units**, of which:

- at least 3 must be from Group A
- Nominated electives as per packaging rules
- up to 2 may be from any currently endorsed Certificate III or above training package qualification or accredited course, provided that no more than 1 is selected from a Certificate III.

Forsythes offers an upgrade for those who wish to have the latest Certificate IV in Training and Assessment. They must have the full certificate IV TAE40116.

### **Component One – CORE TAE16 Upgrade – Ten Units including a DCT and Three Group A electives**

Upgrade the nine core units of competency from TAE40116 to the relevant units of TAE40122.

The completion of the five-days training and optional one day simulated deliveries ( or recorded back in the workplace) achieves nine units of competency in the TAE40122, including all six core and four electives including the three required from group A



**TAE40122 Training Package Rules**

- 6 core units plus 6 elective units
- Minimum of 3 electives from Group A
- Remaining electives may be selected from listed units
- Up to 2 electives from Certificate III or above
- No more than 1 elective from Certificate III
